

2. For every 25 apprehensions, a Certificate of Recognition will be awarded by the Municipal Mayor to the Regular or Auxiliary Eco-Police concerned.

b) Deputized Eco-Police Volunteers

1. For every apprehension, cash award of twenty five percent (25%) of the penalty actually paid shall be given to the deputized volunteer.
2. For every 25 apprehensions, a Certificate of Recognition will be awarded to the deputized volunteer by the Municipal Mayor.
3. The top 10 deputized volunteers based on the number of apprehensions per annum will be given a Plaque of Commendation by the Municipal Mayor

**ARTICLE XXII
TOURIST ENVIRONMENTAL FEE SYSTEM**

Section 75. Tourist Environmental Fee System – It is hereby established a Tourist Environmental Fee, which effectively allocates responsibility for environmental management, protection, remediation and rehabilitation by charging an amount for the use and/or enjoyment of the municipality’s environment and natural resources.

Section 76. Tourist Environmental Fee – A tourist environmental fee shall be collected from all tourists, travellers and guests upon entering the municipality of Daanbantayan’s destinations, as follows;

Tourists	Amount
Locals	₱ 75.00
Foreigners	₱120.00

Section 77. Scope and Coverage - The Tourist Environmental Fee shall be enforced within the jurisdiction of the municipality of Daanbantayan including its municipal waters and natural resources.

Section 78. Collection Sites - Tourist Environmental Fee shall be collected at identified collection sites set-up at any entry points for all travellers/ guests/ tourists.

Section 79. Collection Agents - The Municipal Treasurer shall be the principal collection officer responsible for collecting the Tourist Environmental Fee. To assist her, the Municipal Mayor may appoint a collecting agent.

**ARTICLE XXIII
REVIEW ON TOURIST ENVIRONMENTAL FEE SYSTEM**

Section 80. Review of Tourist Environmental Fee System - The Sangguniang Bayan shall periodically review the system and shall be guided by a study or technical information in order to rationalize the rate of fee to be collected and after due consultation with the stakeholders.

**ARTICLE XXIV
BARANGAY INCENTIVE**

Section 81. Incentive Scheme for Barangays - Ten percent (10) % of the net collection from the Tourist Environmental Fee system shall be allotted to all the barangays of the municipality in the following manner:

- a) Forty percent (40%) thereof shall inure to the host barangay;
- b) Sixty percent (60 %) thereof shall be divided equally to the component barangays.

The said amount shall be appropriated by the barangays concerned to fund their solid waste management and environmental programs in line with the Solid Waste and Environmental Management Plan of the municipality.

**ARTICLE XXV
EXEMPTION ON TOURIST ENVIRONMENTAL FEE**

Section 82. Exemption - The following shall be exempted from the payment of tourist environmental fee:

- a. All residents of Daanbantayan, Cebu shall be exempted from payment of tourist environmental fee, provided he/she shows proof of residency such as municipal ID/ health card, community tax residence certificate, voter's Id and other competent evidence of identity.
- b. All Filipino Senior Citizens, Person's with Disability, Students and Solo Parent shall have twenty per cent (20%) discount in the payment of the tourist environmental fee, provided that the proper identification as Senior Citizen, PWD, student and solo parent shall be presented by the person claiming discount.
- c. Children below twelve years old.*

**ARTICLE XXVI
UNLAWFUL ACTS ON TOURIST ENVIRONMENTAL FEE SYSTEM**

Section 83. Unlawful Acts - The following acts or omissions are prohibited:

- 83.1. Non-payment by any individual, subject to the provisions of Section 82 hereof, of the required Tourist Environmental Fee;
- 83.2. Misrepresentation by any individual of his/ her identity, residency, age, or other personal circumstances to avoid payment of the required fee;
- 83.3. Non-issuance by the designated and authorized collectors of the required official receipts/ tickets in favour of the payees of the tourist environmental fee;
- 83.4. Collection by any individual of tourist environmental fee or charging any form of entrance fee to tourist, travellers, and guests entering the Municipality without proper authority to do so.

Section 84. Penalties for Violations - Any person committing any of the unlawful acts or omissions enumerated in Sections 83.1 and 83.2 hereof shall punished by a fine of not less than Five Hundred Pesos (P500.00) but not more than One Thousand Five Hundred Pesos (P1,500.00).

Any person committing any of the unlawful acts or omissions enumerated in Sections 83.3 and 83.4 hereof shall be punished by a fine of not less than One Thousand Five Hundred Pesos (P1,500.00) but not more than Two Thousand Five Hundred Pesos (P2, 500.00), or by imprisonment for a period not exceeding three (3) months, or both at the discretion of the court.

**ARTICLE XXVII
COMMUNITY INVOLVEMENT**

Section 85. Public Notification - The Constituents of the Municipality shall be regularly informed of acts performed and activities undertaken in connection with the implementation of the Eco-SWM Plan of the Municipality. For this purpose, notices of such acts and activities
